

Hearings with a restorative

approach

Teen court hearings in Buffalo and Pepin Counties use a restorative approach, which means that youth with violations receive requirements to complete from their peers aimed at rethinking their behavior, repairing relationships, and restoring their image in the community. Restorative justice is a 360 degree approach that engages the youth and their family and those harmed with an ultimate goal to change behavior and make things right.





Panelist training

23 new panel members were trained in 2024

Another **3** youth with violations took the oath of confidentiality and participated in restorative questioning and deliberations



Integral parts of the panel member training included developing an understanding of the pillars of restorative justice, practicing effective and equitable questioning strategies, reviewing the hearing process and steps in deliberation, discussing the research behind criminogenic needs, and developing authentic requirements to change behavior and repair relationships.

The Honorable Judge Tom Clark spoke with panel members about his strategies for using a restorative approach in his courtrooms. Students had the opportunity to observe him in action during a sentencing hearing. The training is centered on educating high school students on utilizing restorative justice with their peers.
